(hereinafter called the SETTLER - which expressions shall, unless it be repugnant to the subject or context thereof, mean and include the survivor or survivors of the TRUSTEE and all such persons as are or may be duly appointed as TRUSTEES under THESE PRESENTS) hereby declare and state as follows:-

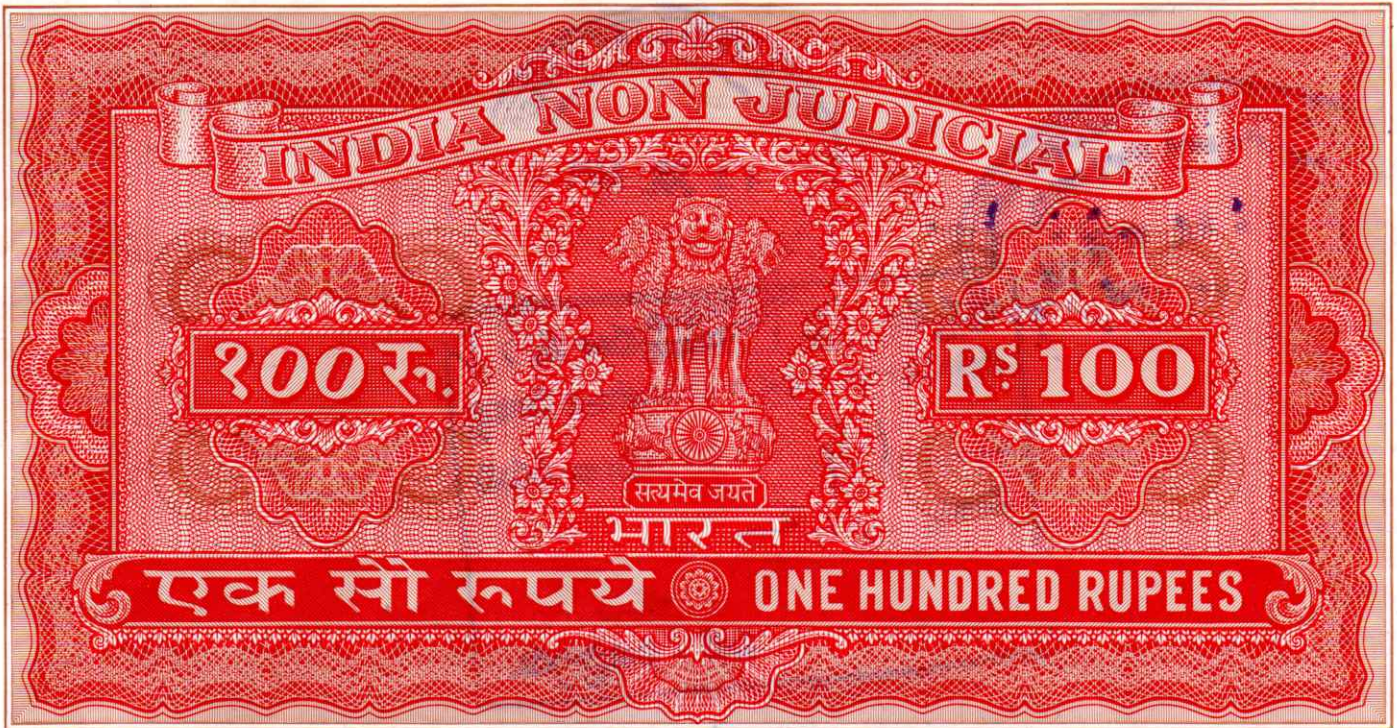
And whereas the settler who is deeply involved in the economic upliftment of the poor in India and is of firm opinion that provision and extension of monetary credit will lead to advancement in the standard of living of masses of poor living in India under penury circumstances, considered it desirable to constitute the trust permanently as an irrevocable trust more particularly for the purposes mentioned above and that the declaration of trust should be made in the manner set out here under;

And whereas, donation amounting to Rs.5,000 have been received from the settler-for the above purposes and further funds are being and will be collected to the trust funds;

And whereas, the settler hereby declare that the said funds and all further funds, donations and contributions in any shape or form to the said funds from time to time and the rents, profits and income thereof and the stocks, funds, properties and securities for the time being representing the same shall be held upon the trust for the objects and purposes and subject to the powers and provisions hereinafter mentioned.

**1. NAME:**
